# **Privacy Policy**

This Privacy Policy describes how PlayoPuff Pty Ltd ("PlayoPuff", "we", "us", or "our") collects, uses, discloses, and protects personal information in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs). We are committed to protecting the privacy of individuals and handling personal information in an open and transparent way. #### 1. Types of Personal Information We Collect

#### 4. Third-Party Services

We may use third-party service providers to assist in the operation of our services, including:

- Plausible Analytics & Google Analytics : To track usage patterns and improve user experience.
- Stripe: For payment processing.

These third parties are required to comply with applicable data protection laws and may only use personal information for the purpose of providing their services to us.

#### 5. Cross-Border Data Transfers

User data may be stored on servers located outside Australia (e.g., Google Cloud Platform). By using our services, you consent to the transfer, storage, and processing of your personal information to these locations, in accordance with this Privacy Policy.

## 6. User Rights

You have the following rights in relation to your personal information:

#### 7. Security of Personal Information
